PERMISSION TO PROCESS AND DISCLOSE INFORMATION AND TO COMMUNICATE WITH YOU

Justrewards hereinafter referred to as "we" will keep your information and the information about those you apply for confidential. You agree to us processing and disclosing your information in the following manner:

1. We will only share your information or the information of any dependant on your Justrewards membership if it is requested by a third party who you have already given your written consent to for the disclosure of this information and the party that we share the information with agrees to keep the information confidential. If we want to share your information for any other reason, we will do so only with your written permission.
2. We may collect, collate, process, store and disclose your information as contained in your application form and any information that is provided to us after the inception of your Justrewards membership:
 - For the administration of the Justrewards programme;
 - For the provision of any services that you or any dependant on your Justrewards membership may require; and
 - For the provision of relevant information to a contracted third party who require such information to render a service to you or any dependant on your Justrewards membership and only if such a contracted third party agrees to keep the information confidential.

3. When providing us with personal information about a dependant on your Justrewards membership, you confirm that they have provided you with appropriate permission to disclose that information to us. This includes consent to the administration of their membership to Justrewards, the provision of any services to them as required, the provision of relevant information to a contracted third party who requires such information to render a service to them.
4. We may provide to any credit bureau or credit providers industry association any information relating to your creditworthiness or any consumer credit information including but not limited to credit history, financial history, personal information and judgment or default history in accordance with the requirements of the National Credit Act, its Regulations, and any other applicable Law.
5. We may communicate to you any changes to your Justrewards membership, including any changes in your contributions or any changes/enhancements to the benefits you are entitled to.
6. Justrewards, as well as contracted third party service providers will keep you updated on information about any offers, rewards or new products that you may be eligible for.

JUSTREWARDS RULES FOR JUSTREWARDS MEMBERSHIP

Justrewards is separate from the Scheme

Justrewards is a separate legal entity from your medical scheme (referred to as 'the Scheme'). It is formally registered under the name AGE Business Management Solutions (Pty) Limited, (registration number 2006\032774\07) which takes care of the Justrewards programme ('Justrewards'). The Justrewards programme is an open programme and available to any eligible person wishing to join regardless of their medical scheme provider.

Rules of the Justrewards programme

Your Justrewards membership fees are separate

The Justrewards membership fees you pay are for Justrewards and are not related to any contributions you may pay to your medical scheme.

Cancellation of Justrewards

Please give notice on the first day of the month if you wish to cancel your Justrewards membership in that month. Otherwise, your Justrewards membership will only end on the last day of the next month. You must be a Justrewards member of Justrewards at the time of the *billing cycle (not the time of the transaction) in order to be eligible for your rewards.

*Billing Cycle refers to the date decided by Justrewards, on which your Justrewards rewards are calculated on a monthly basis.
